REGULAR MEETING

The regular meeting of the Bay County Road Commission, Road Department, was called to order at 9:00 a.m., at 2600 E. Beaver Road, by the Chairman, William Schumacher.

J. Putt – Complimentary comment about Consumers Energy electric power division.

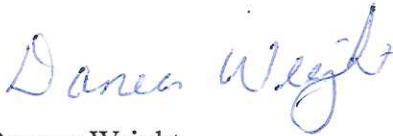
T. Paige – Appreciation to BCRC for pursuing purchase of the former Rose Thrift Shop.
