REGULAR MEETING

The regular meeting of the Bay County Road Commission, Road Department, was called to order at 9:00 a.m., at 2600 E. Beaver Road, by the Chairman, William Schumacher.

Commissioner Shark moved to approve the minutes of the September 4, 2024 meeting. Motion was adopted on a roll call vote:

General Superintendent's Report – Stevenson Road Bridge and 9 Mile opened – Cass/Finn drainage project almost completed – Durapatching, clear vision, gravel lifts, shoulder maintenance and primary mowing – Interviews this week to fill open positions.

The Chairman and Clerk are authorized to sign for the Board. Motion was adopted on a roll call vote:
